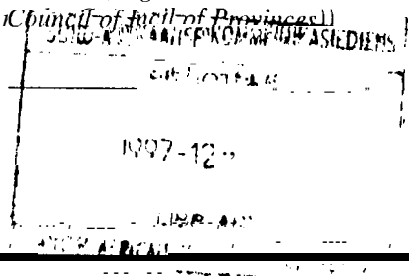

WATER SERVICES BILL [B 65 B-97]

CLAUSE 1

1. On page 8, in line 42, to omit “and” and to substitute “an”.

4. On page 8, in line 50, after “law” to insert:
 and which is likely to cause injury or loss of life
5. On page 10, in line 37, to omit “access road”.
6. On page 10, in line 44, to omit “or”.
7. On page 10, in line 45, after “water” to insert:
 or water for commercial use but not water for industrial use

CLAUSE 4

1. On page 12, in line 36, after “discontinue” to insert “water”.

CLAUSE 7

1. On page 14, in line 20, to omit “access to water for industrial use” and to substitute “industrial use of water”.

CLAUSE 10

1. On page 18, in line 21, to omit paragraph *d)* and to substitute:
 (*d*) provide for tariffs to be used to promote or achieve water conservation.
2. On page 18, in line 29, after “loans” to insert:
 for the provision of water services

CLAUSE 13

1. On page 20, in line 45, to omit “for the water services”.

CLAUSE 14

1. On page 22, in line 9, after “consumers” to insert “, potential consumers”.
2. On page 22, in line 10, to omit “and potential consumers”.
3. On page 22, from line 12, to omit “and of all comments received thereon”,

CLAUSE 21

1. On page 26, in line 16, before “wasteful” to insert “unlawful or”.

CLAUSE 25

1. On page 28, in line 30, to omit “additional”.
2. On page 28, in line 31, after “any” to insert “additional”.

CLAUSE 28

1. On page 30, in line 49, after “services” 10 insert “to water services authorities”.

CLAUSE 33

1. On page 34, in line 14, after “meters,” to insert “acceptable”.
2. On page 34, in line 15, before “settlement” to insert “procedures for”.

CLAUSE 47

1. On page 42, from line 34, to omit subsection (2).

CLAUSE 52

1. On page 46, in line 1, to omit “Main”.

CLAUSE 63

1. On page 52, after line 16, to insert:
 - (4) After assuming responsibility for a function under subsection (2), the Minister may issue a directive to the water services authority to perform that function effectively.

CLAUSE 65

1. On page 54, from line 16, to omit subsection (1) and to substitute:
 - (1) The Minister may prescribe the manner in which an application for financial assistance must be made.

CLAUSE 71

1. On page 56, in line 31, to omit “Regulation Review Committee established by section 75” and to substitute:

portfolio committee of the National Assembly responsible for water services and the select committee of the National Council of Provinces responsible for water services, together hereinafter called the Committee
